**ONEIDA, NY, 08/01/23** — The Oneida Community Mansion House (OCMH) is one of this year's <u>Preserve</u> <u>New York</u> (PNY) grantees. Their **grant of \$18,940 will fund a Cultural Landscape Report**. The Preservation League of NYS and their program partners at the New York State Council on the Arts (NYSCA) are thrilled to help fund this important work.

"We are so grateful to the Preservation League of New York State for this funding." said **Christine Hall O'Neil, Executive Director, Oneida Community Mansion House**. "As part of our long-term commitment to preserving this National Historic Landmark, we are excited to undertake a Cultural Landscape report to better understand our preservation needs, expand our interpretation, and increase accessibility to the Mansion House for years to come."

Thanks to this Preserve New York grant, OCMH will work with a Martha Lyon Landscape Architecture to create a Cultural Landscape Report that will enable the Mansion House to further its historic preservation efforts, expand and diversify its interpretation, and make key improvements to accessibility. This report will dig deeply into the history of the landscape that the utopian Oneida Community inhabited to better understand its significance and the many changes that it underwent over centuries.

At its 2023 meeting, an independent grant panel selected **19 applicants in 17 counties to receive support totaling \$279,936**. Each grant supports important arts and cultural initiatives, as well as economic development related to our state's arts and cultural heritage. Many of these grants will lead to historic district designation or expansion, telling the stories of communities throughout the state and allowing property owners to take advantage of the New York State and Federal Historic Tax Credits. With the announcement of the 2023 awards, support provided by Preserve New York since its launch in 1993 totals more than \$3.7 million to 529 projects statewide. The Preserve New York program is a regrant partnership between the New York State Council on the Arts (NYSCA) and the Preservation League, made possible with the support of the Office of the Governor and the New York State Legislature. The Robert David Lion Gardiner Foundation has generously provided additional funds to support nonprofit projects in Nassau and Suffolk Counties.

Since 1993, Preserve New York has been providing funds to municipalities and nonprofit organizations that need technical, professional assistance to guide a variety of preservation projects. The building condition reports, cultural landscape reports, and cultural resource surveys funded through this program lead to positive outcomes across New York's 62 counties.

The Oneida Community Mansion House is a 501c3 not-for-profit organization with an educational charter from the New York State Board of Regents. It was designated as a National Historic Landmark (NHL) in 1965 as part of the National Survey of Historic Sites and Buildings. The is the highest designation of historical significance that can be awarded by the United States government and is reserved for places that are exceptional because of their ability to illustrate U.S. heritage. Today, there are fewer than 2,600 NHLs in the United States.
